I am pleased to confirm that your business case for funding under the Northern component of the Canada-Ontario Affordable Housing Program (AHP) Extension (2009) has been reviewed and you have been conditionally approved for program funding of \$400,000 in fiscal year 2009-10 and \$800,000 in fiscal year 2010-11.

The response from Service Managers with construction-ready AHP projects has been overwhelming. In order to permit all Service Managers access to the AHP to address their housing needs, we are limiting the amount of funding to Service Managers in some instances. Also, where Northern Service Managers received funding under the Rental Housing component, only a portion of the requested Northern component funding is being conditionally approved.

This conditional approval is based on your ability to commit the funding in accordance with the timelines identified on the enclosure to this letter.

Due to the mandatory timeframes of the AHP Extension (2009), as outlined in the Program Guidelines, the Ministry will be monitoring funding commitments on an on-going basis and reserves the right to withdraw all or part of this funding if these timelines are not being met. Additionally, if the federal funding for the first fiscal year is exhausted prior to the end of the first fiscal year, the Ministry will be under no obligation to fund requests submitted prior to the start of the second fiscal year.

I look forward to continuing our strong relationship as we work together in the months ahead to provide affordable housing in your communities.
