Dear Ministers Zimmer and Moridi:

The Ontario Federation of Indigenous Friendship Centres (OFIFC) is writing you to outline our position on increasing accessibility of provincial employment supports provided for urban Aboriginal people in Ontario through our member Friendship Centres. The OFIFC is moving forward in building strategic alliances with NOSDA and its membership in order to support the OFIFC's ongoing advocacy regarding the expected integration of Employment Ontario (EO) and Ontario Works (OW) as well as the delivery of EO and OW by Friendship Centres. Currently, the existing suite of provincial employment supports available through Employment Ontario's (EO) Employment Service and Ontario Works (OW) are not meeting the needs of multi-barriered clients, including urban Aboriginal people.

Employment Ontario's Employment Service Delivery Sites are geared towards the general public and do not necessarily have staff with the training, resources or capacity to provide culturally informed and appropriate services to the multi-barriered urban Aboriginal population in need of EO services and employment supports. This conforms to 2008-2010 data from the Ministry of Training and Colleges Universities (MTCU) which shows that urban Aboriginal people are accessing EO programming in low numbers.¹

The Provincial Government has acknowledged the need to prioritize the coordination of employment and training services across the province to improve effectiveness for job seekers and employers. Specifically, this would include the integration of EO and OW supports. However, there has been little recognized movement in the area of Employment Services and Training Integration (ESTI).

In an effort to improve the level of service integration urban Aboriginal people receive when accessing EO's Employment Service, the OFIFC continues to advocate for services to be run directly out of the Friendship Centres. NOSDA and the OFIFC are committed in ensuring that EO services are delivered in ways that meet the needs of urban Aboriginal multi-barriered clients and that these EO services are delivered through Friendship Centres. This level of integration should promote further coordination between EO, Aboriginal Skills and Employment Training Strategy (ASETS) and overall Friendship Centre programming as well as support increased numbers of urban Aboriginal people accessing and benefiting from EO's Employment Service in a wholistic, culturally competent space.

Both the OFIFC and NOSDA members have concerns with the existing service delivery model for provincial employment supports as the current system has been unsuccessful in responding to localized labour market issues. In part, these challenges have emerged because CMSMs and DSSABs have not been granted enough responsibility in regards to planning, despite being a more accountable level of government than the MTCU-created Local Planning Boards. In order for all 47 CMSMs/DSSABs to have the option to deliver Employment Ontario programming, a greater level of planning responsibility is required.

The OFIFC and NOSDA are hopeful that we can work collaboratively to ensure that these concerns are addressed in the future integration of EO and OW and the delivery of EO services to urban Aboriginal people. We look forward to hearing from you on the points raised in this letter and to your Ministry's engagement of the OFIFC, member Friendship Centres and NOSDA in pushing the agenda of Friendship Centre delivery of EO services forward.
