RE: Power Dam Special Payment Program

The Council of the Township of Sables-Spanish Rivers is very concerned about the proposed measures introduced in Bill 14, Building Opportunity and Securing Our Future Act (Budget Measures) which phases down or decreases the Power Dam Special Payment Program for hydro-electric stations, poles & wires by 23.53% by 2017, starting in 2015. By my calculation, the payment we would receive in 2017 would be \$8,462.47 less than the property taxes levied on this property in 2000.

These payments currently represent 3.45% of our own purpose revenue. However, when coupled with the accelerated cuts to the Ontario Municipal Partnership Fund (OMPF), the unknown aspects of a new OPP Billing Model and other cuts, the Township of Sables-Spanish Rivers will have to increase property tax rates in order to compensate for the loss of revenue or be forced to significantly compromise municipal services. For this reason, the Council of the Corporation of the Township of Sables-Spanish Rivers respectfully requests that the Province of Ontario reverse the decision to decrease funding to the

Power Dam Special Payment Program and to consider annual increases to the amount of funding by the amount of any change in the Consumer Price Index. Enclosed is a copy of Resolution 2014-261, passed at Council's regular meeting of August 13, 2014.
