and the Journey Together

We are writing to provide an update on the Ontario Early Years Child and Family Centres and the Journey Together initiatives. We thank you for the important work that is underway to support these initiatives, which will help us achieve our shared vision ensuring that Ontario's children and families are well supported by an early years system that is high quality, seamless, and accessible for children and their families.

## **Ontario Early Years Child and Family Centres**

As we move forward with the provincial plan to establish Ontario Early Years Child and Family Centres by 2018, the Ministry of Education (the Ministry) recognizes that we are at a critical point in the planning process where Consolidated Municipal Service Managers (CMSMs)/District Social Services Administration Boards (DSSABs) require information about the allocations to finalize initial plans and work with communities to prepare for implementation. The government remains committed to maintaining its current investment of over \$100M for child and family programs, and continues work to confirm the new funding approach and allocations for CMSMs/DSSABs for this transformation.

As a result of these delays, we are extending the due date to submit initial plans for Ontario Early Years Child and Family Centres from May, 31 2017 to **September 29, 2017.** We recognize that 2018 will be a transition year for some communities, and initial plans for Ontario Early Years Child and Family Centres will reflect local planning across the province.

As identified in the Planning Guidelines for Service System Managers (page 24), CMSMs/DSSABs are required to submit a summary of their needs assessment and initial plans for Ontario Early Years Child and Family Centres. Initial plans must include

an accompanying rationale for site distribution/locations and programs/services to achieve the intended outcomes. We recognize that communities may require time to plan for and transition programs and services in a thoughtful way. In preparation for the transition year, the Ministry is requesting that initial plans describe how programs and services will be delivered beginning January 1, 2018 (i.e., the organizations offering them, where they are located and whether sites are new, enhanced, or relocated) and how the system may be shifted over the course of the year (i.e., May, September, and December 2018).

Additionally, in response to requests for guidance in developing the initial plans, the Ministry has prepared some questions for reflection when finalizing the initial plans (see Appendix A). The Ministry is not expecting CMSMs/DSSABs to answer each individual question, instead consider how the responses have been incorporated into the initial plans. Initial plans for Ontario Early Years Child and Family Centres can be emailed to tpa.edu.EarlyLearning@ontario.ca with a copy to your regional contact in the Early Years Implementation Branch.

As a reminder, service agreements between the Ministry and organizations funded for existing child and family programs will remain in place until December 31, 2017. The new Ontario Early Years Child and Family Centres funding framework and program requirements will be effective January 1, 2018. Therefore, CMSMs/DSSABs will need to have funding agreements in place by January 1, 2018 for the delivery of Ontario Early Years Child and Family Centres. The Ministry is committed to working closely with sector partners to mitigate potential service disruptions to ensure that children and families will continue to be supported during this transition phase. We realize that in order to move forward with a coordinated system of Ontario Early Years Child and Family Centres, a carefully planned transition process is required.

## **Journey Together**

We continue to work closely with partners to enhance access to culturally relevant, Indigenous-led early years programs and services off-reserve, including child care and child and family programs, as set out in *The Journey Together: Ontario's Commitment to Reconciliation with Indigenous Peoples.* 

A number of partners have expressed that additional time beyond the established May 31, 2017 due date would support meaningful and thorough local collaboration to develop program funding proposals. We are also aware that in many cases planning for Indigenous-specific programs and services under the *Journey Together* is occurring in conjunction with planning processes for Ontario Early Years Child and Family Centres.

For these reasons, the due date for off-reserve *Journey Together* proposals will also be extended to **September 29, 2017.** 

The Ministry is aware of the significant work underway in communities to support these initiatives, including the collaboration and engagement opportunities taking place across the province. Much strength in our current system has been identified through these

processes, as well as opportunities to be more responsive to the needs of children and families.
