RE: Five-Year Review of Housing and Homelessness Plans: A Guide for

Ontario Service Managers

As communicated on December 6, 2017, the ministry has committed to sharing with Service Managers resource material to help with the five-year review of Housing and Homelessness Plans. Attached you will find a "Five-Year Review of Housing and Homelessness Plans: A Guide for Ontario Service Managers" to support you during the review process.

Please recall that as part of the review process, Service Managers are required to provide a written report of their review to the ministry to summarize main revisions to the plan including changes driven by the 2016 update to the policy statement (Policy Statement: Service Manager Housing and Homelessness Plans), changes in local priorities, etc. In the December 6 memo, the ministry had clarified that the *HSA* provides some flexibility with regards to the timing of the five-year review: Service Managers must *initiate*, but not necessarily *complete* their review by the fifth anniversary of their plan. In terms of more specific timing, Service Managers are asked to complete and submit their review report and revised plans to the ministry by June 30, 2019. Consultations with the public and the Minister need to take place before a revised plan can be approved by the service manager. Service Managers needing more time to complete their process are asked to advise the ministry of their expected completion date.

The review process provides the opportunity for Service Managers to update their Housing and Homelessness Plans to reflect the changing environment and to ensure consistency of local plans with the HSA and the revised policy statement released in

2016. In addition, Service Managers will want to consider opportunities to leverage the National Housing Strategy.

As a next step, the ministry will be hosting online webinar sessions for Service Managers in order to walk through the guide and provide Service Managers with an opportunity to ask questions regarding the guide and the five-year review process. The webinar sessions are being organized by region according to the following schedule:

- Northern regions: April 19, 2018 3:00 pm to 5:00 pm
- Central region: April 18, 2018 9:00 am to 11:00 am
- Western region: April 17, 2018 2:30 pm to 4:30 pm
- Eastern region: April 23, 2018 10:00 am to 12:00 noon

We encourage all Service Managers to use the guide and participate in the regional webinar session.
