Dear Mr. Dominelli:

At the December 13<sup>th</sup>, 2017 Council Meeting your requests were addressed regarding the Ambulance Station. Council resolution 17-465 is attached hereto which speaks to the issues.

Item #1: The Municipality is not interested in selling the building;

**Item #2:** A new main door will be installed at our approximate cost of \$2,500 - \$3,000;

Item #3: The request to install a new automatic transfer switch to power up the building from the existing genset at the Water Treatment Plant has been deferred to the 2018 Finance Committee. Council would like to hear your reasons for requesting this connection:

**Item #4:** Upon review by our Chief Building Inspector Council understands this would be a substantial expense that would involve significant structural modifications and the involvement of a structural engineer. Therefore, changing the two 10 foot doors to one 20 foot door is not a consideration at this time.

## RESOLUTION NO. 17-465

**BE IT RESOLVED THAT** regarding the Ambulance Station, the Municipality is not interested in selling the building to Manitoulin-Sudbury District Services Board *(MSDSB)*;

**FURTHER THAT** the Municipality is agreeable to include the following in the 2018 municipal budget as requested by MSDSB:

The installation of a new main door (approximate cost \$2,500 - \$3,000):

**FURTHER THAT** the installation of a new automatic transfer switch to power up the ambulance building from the existing 200Kw genset at the Water Treatment Plant will be deferred to the Finance Committee;

**FURTHER THAT** regarding the overhead garage doors, due to the substantial expense which would involve significant structural modifications and include the involvement of a structural engineer, the request to change the two 10 foot doors to one 20 foot door is not a consideration at this time.
