Extension of Timeline for the Five-Year Review of Housing and

Homelessness Plans

I am writing to provide an update on the deadline of the five-year review of your Housing and Homelessness Plans. The Ministry received a request from the Association of Municipalities of Ontario (AMO), on behalf of its members, to extend the deadline to the end of calendar year 2019 to allow new municipal councils added time to determine strategic and financial plans related to housing, and for Service Managers to consider potential changes in relation to program roll-out under the National Housing Strategy.

I am pleased to share that the Ministry is able to accommodate this request.

Service Managers are reminded that, pursuant to Sections 7, 8 and 9 of the *Housing Services Act, 2011 (HSA)*, consultations with the public and the Minister are to take place before an amended plan can be approved by the Service Manager.¹ As part of the consultation with the Minister, completed review reports and amended plans are to be submitted to the Ministry by December 31, 2019 via email to housing.research@ontario.ca.

Under the *HSA*, once a Service Manager submits its local Housing and Homelessness Plan to the Ministry, there is a 90-day period for the Minister to provide comments for
