DEMOGRAPHIC CHARTBOOK – HIGHLIGHTS

It is well documented that Canada's population is aging. This is evident in the Districts of Sudbury and Manitoulin: the catchment area for the Manitoulin-Sudbury District Services Board. Key components of the population aging phenomenon include:

- A net decrease and relative decline in the 0 to 4, 5 to 14 and 15 to 24 age groups
- A large increase and proportionate increase in the 55 to 64, 65 to 74 and 75 years of age and over age groupings
- Limited in-migration, primarily in the retirement age groups, along with out-migration in the younger age groups


Implications of this aging-in-place phenomenon may be manifested in the following ways that have repercussions for the Manitoulin-Sudbury District Services Board:


- Fewer young children in the area may have an impact on the demand for Child Care/Day Care spaces
- Fewer young and working aged adults (eg. aged 15 to 54 years) can mean more of a tax burden on older adults who may be on fixed incomes
- An aging population may have implications on social housing as persons on fixed incomes may have increasing difficulty maintaining and living in their own homes
- An aging population may have implications on Emergency Medical Services as the need for medical services tends to increase with age



Sub-District: LACLOCHE (Towns and Townships)




Between 1996 and 2006, the population of the sub-district of LaCloche, consisting of the Townships of Baldwin, Nairn & Hyman, Sables-Spanish Rivers and the Town of Espanola, **decreased by 2.2%**. Components of this decline included a decline of 40.9% of persons between the ages of 0-4, a decline of 7.5% between the ages of 5-14, a decline of 19.3% in the 15-24 years of age category and a decline of 7.2% of the 25-54 years of age category. Gains were experienced in the upper age categories: a 44% increase in the 55-64 age category, an increase in the 65-75 years of age category of 25.5%, and 26.2% increase in the 75 and over age category. A graphic depiction of this data is produced in Graphs 1.1 through 1.8.









Between 1996 and 2006, the population of the Township of Sables-Spanish Rivers decreased **by .9%**. Components of this decrease included a decline of 44.9% of persons between the ages of 0-4, a decline of 10.7% between the ages of 5-14, a decline of 34.7% in the 15-24 years of age category and a decline of 3.9% in the 25-54 years of age category. However, increases were experienced in the upper age categories: a 47.1% increase in the 55-64 age category, a decrease in the 65-74 years of age category of 27.3%, and a 25.8% increase in the 75 and over age category. The Median Age increased from 35.4 to 44.3 years of age between 2001 and 2006(4).

Between 1996 and 2006, the population of the Town of Espanola decreased **by 2.8%**. Components of this decrease included a decline of 39.7% of persons between the ages of 0-4, a decline of 15.1% between the ages of 5-14, a decline of 6.0% in the 15-24 years of age category and a decline of 9.3% in the 25-54 years of age category. However, increases were experienced in the upper age categories: a 40.2% increase in the 55-64 age category, an increase in the 65-74 years of age category of 19.5%, and a 25.0% increase in the 75 and over age category. The Median Age increased from 36.1 to 44.3 years of age during that 10-year period.

Between 1996 and 2006, the population of the Township of Baldwin decreased **by 18.8%**. Components of this decrease included a decline of 44.4% of persons between the ages of 0-4, a decline of 26.3% between the ages of 5-14, a decline of 42.9% in the 15-24 years of age category and a decline of 17.7% in the 25-54 years of age category. However, increases were experienced in the upper age categories: a 25.0% increase in the 55-64 age category, a decrease in the 65-74 years of age category of 11.1%, and a 16.7% increase in the 75 and over age category. The Median Age increased from 35.4 to 44.3 years of age during that 10-year period.

Between 1996 and 2006, the population of the Township of Nairn & Hyman increased **by 21.2%**. Components of this increase included a decline of 16.7% of persons between the ages of 0-4, a decline of 8.3% between the ages of 5-14, a decline of 16.7% in the 15-24 years of age category and an increase of 10.0% in the 25-54 years of age category. In the upper age categories: an 88.9% increase in the 55-64 age category, an increase in the 65-74 years of age category of 200.0%, and a 100.0% increase in the 75 and over age category. The Median Age increased from 33.3 to 44.8 years of age during that 10-year period.



Sub-District: MANITOULIN (Towns and Townships)




Between 1996 and 2006, the population of the Manitoulin Sub-District, consisting of the Townships Assiginack, Barrie Island, Billings, Burpee & Mills, Central Manitoulin, Cockburn Island, Gordon, and Tehkummah, and the Towns of Gore Bay and Northeastern Manitoulin & The Islands, **increased by 6.0%**. Components of this increase included a decline of 28.2% of persons between the ages of 0-4, a decline of 23.1% between the ages of 5-14, a decline of 4.2% in the 15-24 years of age category and a decline of 4.7% of the 25-54 years of age category. Gains were experienced in the upper age categories: a 55.1% increase in the 55-64 age category, an increase in the 65-75 years of age category of 23.0%, and 42.6% increase in the 75 and over age category. A graphic depiction of this data is produced in Graphs **2.1 through 2.8**.



Between 1996 and 2006, the population of the Township of Assiginack decreased **by 3.3%**. Components of this decrease included a decline of 53.8% of persons between the ages of 0-4, a decline of 0.0% between the ages of 5-14, a decrease of 22.7% in the 15-24 years of age category and a decrease of 18.6% in the 25-54 years of age category. Increases were also experienced in the upper age categories: a 56.5% increase in the 55-64 age category, an increase in the 65-74 years of age category of 9.1%, and a 44.4% increase in the 75 and over age category. The Median Age increased from 39 to 48.5 years of age during that 10-year period.

Between 1996 and 2006, the population of the Township of Barrie Island stayed the same. Components of this included a decline of 100.0% of persons between the ages of 0-4, a decline of 0.0% between the ages of 5-14, a decline 100.0% in the 15-24 years of age category and an increase of 33.3% in the 25-54 years of age category. There was no increase in the 55-64 age category, an increase in the 65-74 years of age category of 50.0%, and no increase in the 75 and over age category. The Median Age increased from 46.7 to 63.2 years of age during that 10-year period.

Between 1996 and 2006, the population of the Township of Billings decreased **by 9.7%**. Components of this decrease included a decline of 72.7% of persons between the ages of 0-4, a decline of 71.4% between the ages of 5-14, a decrease of 18.2% in the 15-24 years of age category and a decrease of 14.6% in the 25-54 years of age category. However, increases were experienced in the upper age categories: a 25.0% increase in the 55-64 age category, an increase in the 65-74 years of age category of 28.6%, and a 300.0% increase in the 75 and over age category. The Median Age increased from 41 to 53.6 years of age during that 10-year period.

Between 1996 and 2006, the population of the Township of Burpee increased **by 47.7%**. Components of this increase included a decline of 50.0% of persons between the ages of 0-4, an increase of 60.0% between the ages of 5-14, an increase of 250.0% in the 15-24 years of age category and an increase of 23.5% in the 25-54 years of age category. Increases were also experienced in the upper age categories: a 71.4% increase in the 55-64 age category, an increase in the 65-74 years of age category of 50.0%, and a 40.0% increase in the 75 and over age category. Between 1996 and 2006, the population of the Township of Tehkummah increased **by 8.3%**. Components of this increase included a decline of 60.0% of persons between the ages of 0-4, an increase of 16.7% between the ages of 5-14, a decrease of 33.3% in the 15-24 years of age category and a decrease of 12.9% in the 25-54 years of age category. In addition, increases were experienced in the upper age categories: a 100.0% increase in the 55-64 age category, an increase in the 65-74 years of age category of 11.1%, and a 66.7% increase in the 75 and over age category. The Median Age increased from 43.3 to 54 years of age during that 10-year period.




Manitoulin-Sudbury District Services Administration Board Population Comparison - Manitoulin-Sudbury Districts based on 2006 Census



Manitoulin-Sudbury District Services Administration Board Population Comparison - Sudbury District based on 2006 Census








