1) Please describe how you engaged and consulted with partners within your community in this process, as well as your approach to continued engagement.

April 2017 1)Aboriginal Cultural Competency Learning Sessions First Steps were held in Chapleau and LaCloche. The purpose of the sessions was to provide an introduction to Aboriginal cultural competency knowledge with a historical review of Canadian history. Themes and discussions included: 1. Key historical legislative pieces in Canada's history with its Aboriginal people. 2. Results of Canada's colonial legacy policies. 3. What kind of change is being called for in our educational and early learning system. 4. What is the intent and purpose of the Truth and Reconciliation Commission recommendations? What are our individual roles in the Reconciliation relationship? 2)Aboriginal Cultural Competency Learning Sessions Second Steps were held in Chapleau and LaCloche. The purpose of the sessions was to build on the knowledge gained in the first steps session by 1. Building a common understanding of Reconciliation and Cultural Competency. 2. Understanding our own social location. 3. Understanding the need for a trauma informed approach when working with Indigenous children and families and 4. Building reconciliation relationships.

**May 2017 Culminating Workshop** for all participants of First and Second Step sessions (including those who participated in 2016). The goals of the culminating working shop were to 1. synthesize cultural competency learning into beginning practices by each region. 2. Recognize and acknowledge the continuum of each rural geographic regions 'readiness' for implementation of cultural competency and organizational practices as service providers to both Indigenous and Non-Indigenous families, this includes recognition that Indigenous families and communities will be on their own continuum of 'readiness' as well and 3. Introduce and create partnerships between Manitoulin-Sudbury Best Start Network service providers and First Nation organizations working with Indigenous children and families in each geographic region of the Manitoulin-Sudbury District Services Board service area.

The day after the culminating workshop, a small group met (Catalyst Consulting, Manitoulin-Sudbury District Services Board, Kenjgewin Teg and Sagamok First Nation Education), the purpose of the meeting was to review the feedback from the culminating session and summarize the steps needed to move forward. It was determined that the first and second steps sessions needed to be offered in the Sudbury East region of the Manitoulin-Sudbury District Services Board service area, sessions have been scheduled for the fall of 2017. In **September 2017** a meeting was held to further identify the steps needed to support proposal development. Participants included Manitoulin Family Resources, Our Children Our Future, Chapleau Child Care Centre, Kenjgewin Teg and Manitoulin-Sudbury District Services Board. It will be of critical importance to continue to engage our partners, the Aboriginal Advisory Committee, Best Start Network and Local Service Provider Networks will support ongoing discussion and program development. The Manitoulin-Sudbury District Services Board will continue to work closely with Kenjgewin Teg and the Aboriginal Advisory Committee to develop a strategy to engage family and staff it is recognized that family and staff engagement activities are needed to both develop and monitor the ongoing effectivess of our the initiatives proposed. 2) Who lives in and/or accesses early years programs and services in this region (please support with demographic data if available)? What are the available child care and family programs and services? What are the gaps/needs affecting Indigenous children and families?

The demographic data is limited regarding Indigenous children and families in our district. The chart displayed in the NHS data tab shows the 2011 Aboriginal identity information we have as reported through the National Household Survey, a non-mandatory survey of the population which replaced the mandatory long form Census in 2011. This information includes supressed data. We expect the Aboriginal Identity data for the 2016 census to be released in October 2017, we will be reviewing this data as soon as it becomes available. Based on the 2011 NHS data, our communities that have data available have between 5 and 17% of the population self identifying as Aboriginal. The NHS tab includes a column indicating the presence of child care and family support programs currently available. The organizations offering licenced child care and family support programs acknowledge that they are not offering culturally responsive programming to the degree that they would like to. They have indicated that they lack the confidence and knowledge to make appropriate connections and deliver programming specific to Indigenous culture.

# 3) What are the desired outcomes for Indigenous children and families in this region with respect to child care and child and family programs? Short term and long term goals?

*Vision:* "Creation of a generation who naturally dismantle oppression" In order to achieve the vision, a number of goals have been identified: 1. Increased access to culturally relevant services and programs for Indigenous families. 2. Enhanced and accurate Indigenous content. 3 Fostering Indigenous Identity. 4. Supporting Indigenous and non-Indigenous people develop capacity. Key Messages: 1. All children, families and staff have a sense of belonging and a strong positive identity. 2. Indigenous ways of being and knowing is acknowledged and recognized in all aspects of the work. 3. Families and Educators are key to children having a strong, positive identity and 4. For reconciliation to be achieved we all need to grow and change.

# 4) Is there any other relevant information you would like us to know about child care and child and family programs in the local community?

The child care and child and family programs are committed to improving outcomes for children and families in our community. They are committed to achieving the goals outlined above and recognize that additional professional learning and reflection is necessary to achieve our vision. The child care and family programs in our district have lower enrolment than in urban centres and therefore at this time it is not deemed necessary to build new programs off reserve, instead the existing programs need additional support to ensure that they are meeting the needs of Indigenous children and families. We are however proposing that a place of learning be established on Manitoulin Island that would serve as research and training hub and cultural learning centre for child care programs, family programs (OEYCFCs), educators and families.

5) What program impacts are important to Indigenous children and families? How could these impacts on children, families and the community be measured? (e.g., assessment of developmental health and well-being at school entry, number of children accessing programs in traditional languages ).

More time is needed to determine program impacts and develop outcome measures. The Manitoulin-Sudbury District Services Board, KTEI, OEYCFC Program Leads and the DAC will work together to ensure appropriate evaluation strategies are developed.

6) Please describe how all of the proposed program(s) address the needs and outcomes identified above, and align with the broader service system plan(s) in your region, existing government direction and priorities (e.g., Ontario Early Years Child and Family Centres, increased access to child care and services).

The proposed program will support the delivery of culturally relevant programming that includes history, language and land based learning. The proposed program will support appropriate teaching methods based on Aboriginal learning styles, support postive Aboriginal self-identity and support connections to extended family and the community. As the staff working in Ontario Early Years Child and Family Centres and Child Care programs improve their capacity to deliver culturally relevant programs, have access to safe spaces to explore difficult conversations and ask questions and have ongoing support to enhance services we believe programs will have an increased understanding of Indigenous peoples, greater empathy, will honour cultural identity and eventually achieve the vision of a generation who naturally dismantle oppression. Indigienous children and families are more likely to access programs where they feel a sense of belonging, that enhances their well-being and supports their ability to express themselves while enaging in learning. Meaningful engagement of staff and parents and extended family is critical to the success of early learning programs. The proposed program supports the view of the Manitoulin-Sudbury District Services Board that all children and families in our catchment area have the right to expereinces that promote healthy, holistic child and family development. The Manitoulin-Sudbury Best Start Network strives to promote resources and expertise across the system to increase awareness and access, support collaborative services that are innovative and flexible and support the holistic development of children. The proposed program will increase access to culturally relevant programs and services for children and families which will increase awareness and access of other community services leading to the holistic development of children.

# 7) Please describe how the proposed program(s) would increase access to services within your region.

As outlined above, the proposed program aims to improve access to culturally relevant programs across the Manitoulin-Sudbury District Services Board catchment area. By enhancing the capacity of programs to deliver culturally relevant services throughout the district families will have improved access.
