## **Employment Ontario**

Employment Ontario assists those who are unemployed get training, skills and experience to achieve their goals. The program connects people looking for work with employers looking for workers. The new employment service model will provide clients with a single, enhanced point of access to services that are customer-focused, flexible and responsible to local community needs.

Training is available to Ontario Works and Ontario Disability Support Program participants to enhance their skills and abilities. We currently offer the following: **First Aid / CPR**, **WHMIS**, **Smart Serve**, **Service Excellence** , **Safe Food Handling**.\*

These sessions are normally scheduled on a monthly basis by municipality offices. This training has been made available, free of charge, to member municipalities who have in turn provided the DSB with a free meeting place for the sessions.

## **Ontario Works**


Ontario Works provides financial and employment assistance to people who are in temporary financial need. Assistance includes income support for food, clothing and shelter as well as preparation for employment such as resume and interview workshops, job-specific training or access to basic education.

Temporary Care Assistance provides support for children in financial need while in temporary care of an adult who does not have a legal obligation to support the child.

## **Ontario Works Caseload Statistics – May 2021**

A case refers to a single individual or a family unit on social assistance. Case counts in the charts below include both active and suspended cases. The **number of beneficiaries** is the total number of individuals and heads of family units on social assistance plus their dependents (i.e. spouses, dependent children and dependent adults).

LCG: Large Community Grouping






Figure 3: Total Beneficiaries – 2020 to 2021




Figure 5: Ontario Works Case Earnings and Exits




Figure 2: Total Cases by LCG – 2020 to 2021




Figure 4: Total Beneficiaries by LCG – 2020 to 2021





Figure 6: Applicants by Municipality – May 2021
